

Healing Touch for Animals® and Young Living Essential Oils Coordinator Opportunity

Essential oils are an important part of the Healing Touch for Animals® (HTA) curriculum and are formally introduced in Level 3. However, many students are interested in learning more about the oils sooner than Level 3.

HTA Coordinators *are not* required to be a Young Living distributor nor in the HTA downline. However, HTA Coordinators who are with Young Living and in the HTA downline are presented with a unique opportunity!

In addition to the HTA Coordinator Compensation, Coordinators can also earn a commission directly from Young Living. If Coordinators choose to actively work the Young Living business and are in the HTA downline during their duties as HTA Coordinators, Carol Komitor will help them build their business by assigning the Sponsorship of certain HTA students under the Coordinators' Young Living Sponsor IDs.

What Does this Opportunity Really Mean?

Building a Young Living business can be very rewarding as well as lucrative. Take a look at the generous [compensation plan](#) from Young Living.

HTA has many Coordinators who work their YL business and are receiving monthly commission checks from Young Living. Young Living's compensation plan makes it easy to build a downline that pays for your Essential Rewards monthly auto-ship and much more! In addition, the HTA office has a support team in place dedicated to helping our HTA Coordinators build their HTA Young Living team!

Enroller / Sponsor Guidelines

- Coordinators must have an active Young Living account and in the HTA downline in order to benefit.
- Carol Komitor (603679) is the Enroller under most circumstances. This ensures HTA students are aware of their placement within the HTA organization.
- During HTA courses, local area students who sign up with Young Living are placed under the Sponsorship of the Coordinator.
- The Instructor chooses where out of state students are placed in the HTA downline.
- If a Coordinator is not interested in working the YL business or is not in the HTA downline, the Instructor has the discretion to choose the placement of students signing up with Young Living.
- If HTA students call the office for support signing up for YL, their Sponsorship is placed under the Coordinator from the course they attended.
- There are many ways a Coordinator can present the Essential Oils to potential students. For instance, if you are having a community event to promote HTA, and HTA has paid the fees for the event, Carol Komitor must be listed as the Enroller and the Coordinator as the Sponsor.

- If you know you have interested students, we recommend you plan a presentation outside of class time. Depending on the location and Instructor of your HTA course, we may be able to arrange for the Instructor to present the oils.
- If you have made contact with a potential YL distributor through the course of doing your duties as an HTA Coordinator, Carol Komitor must be listed as the Enroller.
- If an HTA student does not sign up at the time the oils were first presented, but the original contact came about because of HTA, Carol Komitor must be listed as the Enroller.
- Many HTA contacts could potentially become friends. While we cannot police who is a friend and who is a contact from HTA, we trust in the integrity of our Coordinators.
- There are also many ways to share the oils outside of HTA. If you sign up personal friends/contacts, then you should retain both Enroller/Sponsor status during sign-up.
- Note: Financial success with Young Living requires commitment, effort and sales/support skills. Effort = Reward
